

Brookings Driver's Education Registration 2017

Read Carefully Before Completing Registration

Attached please find the registration form for this year's Summer Drivers' Education Program. This form must be completely filled out and returned to the Brookings High School office along with a check payable to **BHS Driver's Education** in the amount of \$285.00 by **April 21st** before the student will be considered registered for the class. Space is limited so please register promptly.

Current Brookings High School students and 8th grade students who are 14 years of age prior to May 24th may register. Brookings High School students will be given priority. Registration forms will be available at the high school office between the hours of 7:30 a.m. and 4:00 p.m. or online on the Brookings School District website.

There are two sessions that will be offered for this year's Driver's Education Program **classroom instruction**.

Please remember when signing up that students must attend 30 hours of class and 6 hours of driving to complete the requirements. One additional class day is offered as a make up for students who have conflicts. It is not possible to schedule around all activities. Students who commit to driver's education may have to miss another activity in order to meet the required hours. These are state requirements and are not negotiable.

Session 1 (Before school is out) May 2, 4, 5, 9, 11, 16, 18, 19, 23, 24, 25 (25th is a make-up date)

5:00 to 8:00 p.m. 3 hours each evening x 10 days = 30 hours

Session 2 June 5, 6, 7, 8, 9, 12, 13, 14, 15, 16, 19 (19th is a make-up date)

7:00 to 10:00 a.m. 3 hours each day x 10 days = 30 hours

Driving begins in June

Please check schedules carefully for any conflicts.

2017 Summer Driver's Education Policies

Conduct...All participants are expected to abide by the rules, regulations, and directions provided by the course instructors. Failure to do so will subject participants to dismissal from the Driver's Education program.

Certificate....Students will receive a certificate of completion for licensure and insurance purposes upon successful completion of all classroom and driving hours. Students who do not complete 100% of the time required will not receive this certificate.

Refunds...will **NOT** be given to students who do not successfully complete the course of study (classroom and driving) due to unsuccessful performance, misconduct, absences, or because the student's family changes their plans after the final registration deadline of April 21st.

Please be sure to confirm your summer schedules before registering for either session.

All classroom and behind the wheel Instructors are Certified Driver's Ed Instructors.
